A Biographical Dictionary of Notable Living Men and Women, Vol. 31, page 509, in its biography of Chapel says in part:

"Comm. 2d Lt., U.S. Marine Corps, 1926; 1st Lt., 1933; served with 5th Regt., Nicaragua, 1927; on board U.S.S. California, 1929-31; shore stations 1931-33; 4th Regt., Shanghai, China, 1933-36; comd. anti-pirate guard on Am. vessel, Yangtze River, China; comd. armed body guard about President Roosevelt at his 1st inauguration; judge advocate, 5th U.S. Naval District Gen. Court Martial, 1936-37; retired September 1, 1937."

Regarding his work after retirement from the Corps, WHO'S WHO IN AMERICA says on the same page: "Ednl. dir. Twenty-nine Palms (Calif.)

Air Academy, U.S. Army Air Corps Advanced School of Motorless Flight (gliders), 1942; supervised training of more than 12,000 Navy aviation officers and enlisted men in Consolidated-Vultee Aircraft Corp. Flight and Maintenance Schools, U.S. Naval air stations, North Island, Camp Kearney, and Hutchinson, Kan., 1942-44; motion picture dir. in charge prodn. Army Air Forces training films, Gen. Administrative Offices, Consol.-Vultee Aircraft Corp., San Diego, Calif., 1944-45; chief, Research and Development, Northrop Aeronaut, Inst., div. Northrop Aircraft, Inc.; and other aircraft cos. since 1948."

CAVALRY Served as enlisted man in horse cavalry, Iowa National Guard.	ANNAPOLIS Educated in public schools of Iowa, at State University of Iowa, Missouri University, and U. S. Naval Academy, at Annapolis, Md. Degrees: A.B. and B.S. in Engineering.	MARINE Served as officer of the regular U.S. Marine Corps for eleven years, aboard the U.S.S. California, ashore in campaigns in Nicaragua and China, as Judge Advocate, 5th U.S. Naval District, and retired with honor in 1937.	ENGINEER Aeronautical and ordnance engineer, licensed by the State of California as a Professional Mechanical Engineer, Certificate No. 1992, dated June 30, 1948.
AUTHOR Chapel is the author of twenty-three major scientific and technical books on firearms, aviation, electronics and law-enforcement; the author of the Boy Scout Merit Badge Pamphlet on Aviation; and one of the authors of a new high-school text on biology.	ANTI-COMMUNIST Assemblyman Chapel fought communism by removing the Communist Party from the ballot in California by means of his A.B. 52, Chapter 1217, Statutes of 1953, now cited as Sections 2540, 2540.4, and 2540.9, Elections Code.	CONSTITUTION Chapel also fought communism by authoring and obtaining the enactment into law of his A.B. 3280, Chapter 363, Statutes of 1951, then cited as Sections 10021, 10022, and 10053, Education Code, which required the teaching of courses in the principles of State and local government, and American ideals in all schools of California.	SAN DIEGO FREEWAY Assemblyman Chapel has been publicly commended by Senator Randolph Collier, Democrat, for including the San Diego Freeway in the State Highway System, and for working vigorously for its completion through his Assembly District.	NO TAX INCREASE Assemblyman Chapel as a Member of the Assembly Committee on Revenue and Taxation for nearly twelve years has opposed new and increased taxes but supported essential bills for schools, veterans, senior citizens, and the physically handicapped.	
ATOMIC ENERGY Assemblyman Chapel was the author of Assembly Bill No. 813, which became Chapter 1219, Statutes, Vehicle Code, regarding the safe transportation of nuclear fission (atomic energy) products.	TEACHERS Assemblyman Chapel for nearly twelve years has received letters of commendation and thanks from officers and members of the California Teachers Association for his support of the public school system and the California Teachers Association program.	VETERAN Chapel is a Member of the Veterans of the Foreign Wars of the United States. His A.B. 1646, Chapter 616, Statutes of 1951, then cited as section 205, Revenue and Taxation Code, defines the rights of overseas veterans. In addition, he has supported the Cal-Vet law and some loan laws.	GOOD CITIZEN Assemblyman Chapel was awarded the Sons of the American Revolution Gold Medal for Good Citizenship because he has consistently supported anti-communist bills, anti-narcotics bills, and anti-pornographic bills.	ANTI-LOAN SHARKS Assemblyman Chapel was the author of A.B. 3192, the first anti-loan shark (ten-percenters) law in California, which became part of Business and Professions Code in 1953. He also was the author of A.B. 1684, regulating loan sharks, which became part of Civil Code in 1957.	PROTECT BEACHES Chapel was the author of the amendment to A.B. 3402 of the 1956 General Session (Chapter 1724, Statutes of 1956) which prohibits oil drilling from a point north of Santa Monica to Point Vicente, near San Pedro, except where cities own their own right to vote on oil drilling, thus preserving to the cities the right of home rule.
REDONDO BEACH Chapel obtained, in 1952, an emergency appropriation of \$20,000 for the repair, restoration and protection of the City of Redondo Beach (1952 Budget Bill, Item 2838; A.B. 1, now cited as Chapter 3, Statutes of 1952).	APPROPRIATIONS Chapel did not stop here. His second appropriation for Redondo Beach was in the amount of \$150,000 1954 Budget Bill, Item 2825; A.B. 1, Chapter 1, Statutes, 1954.	REDONDO BEACH HARBOR Chapel also obtained the appointment of the Governor's Commission to study the feasibility of a Harbor at Redondo Beach, which obtained the approval of the U.S. Army Corps of Engineers, resulting in the present Federal, State, and local support of the Redondo Beach Harbor.	SALT-WATER INTRUSION Chapel obtained the \$750,000 appropriation to combat salt water intrusion at Manhattan Beach, which was a pilot study that protected cities as far inland as Inglewood and Westchester (L. A. 45). This is Chapel's A.B. 2712, Chapter 1500, Statutes of 1951.	MANHATTAN TIDELANDS Chapel obtained a tidelands grant for Manhattan Beach with his A.B. 3619, Chapter 1427, Statutes of 1955.	MANHATTAN BEACH PIER In 1956, Chapel obtained an appropriation of \$240,000 for the State of California to take title to and rebuild the pier at Manhattan Beach, with provision for Los Angeles County to maintain and operate the pier, found in Budget Bill of 1956, Item 4011; A.B. 1, Statutes of 1956.
SOUTH BAY STATE COLLEGE Assemblyman Chapel was the author of the Assembly Bill establishing the new South Bay State College, sponsored Senate Bill 15 and was the Assembly floor leader for the passage of this bill which became part of the Education Code, Chapter 65, Statutes of 1960. Five million dollars was appropriated in 1962 for the purchase of the land.	NATIONAL GUARD Chapel has supported bills for California National Guard armories and will introduce in 1962 a bill for re-organization of National Guard Reserve.	NO POLLUTION Chapel was the author of A.B. 1086, Chapter 603, Statutes of 1957, Section 13000 of the Water Code and A.B. 1087, Chapter 604, Statutes of 1957, Sections 24155 to 24159, inclusive, of the Health and Safety Code, protecting our beaches against pollution from sewage and other sources.	NO NARCOTICS Among the many other laws of which Assemblyman Chapel was either the author or floor leader was his own A.B. 2378, enacted in 1959, to provide for a National Test for narcotic offenders. This is one of the most effective anti-narcotic laws in the California statutes.	NO SMUT BOOKS Assemblyman Chapel has co-authored and supported bills to stop the flood of indecent literature in California. In 1963, he will introduce his own new bill based upon laws now effective in other states.	46TH DISTRICT The above are only some of the many bills and laws of which Chapel was the author, co-author or floor leader. Every community in the Assembly District, including Venice, Palmdel Rey, Westchester, El Segundo, Manhattan Beach, Hermosa Beach, Redondo Beach, Torrance, Palos Verdes Estates, Rolling Hills, Rolling Hills Estates, Fort Lauderdale, San Juan Capistrano, Santa Catalina Island, is protected by Chapel's laws.
