

Gilliss also admitted that the timing of the announcement of the MTA proposal was gared to the day of the Governor's inauguration, and that the MTA had been remiss in not informing the County Super visors of the proposal before-hand. tional arguments. "I am completely for a rapid transit system, and I think that several common-sense avenues are open to provide it for the people of Los Angeles County." Hahn said "But I will fight any proposal to put additional tax owners."



proposal to finance the \$649 million rapid transit system through property taxes on Los Angeles County residents. Supervisor Kenneth Hahn, leader in the fight against the MTA proposal, pointed out that the Supervisors will make their opposition known to local State Legislators, who will have the opportunity to ap-prove or deny MTA's request to become a taxing agency. "The responsibility of taxing property rests in California with those who are elected by the people. This gives the peo-ple the right to control their some check on heavy taxes."
