

# Teenagers Will Help Handicapped

The Crippled Children's Society of Los Angeles is receiving help this summer from a welcome source—teenagers.

A group of teenagers, mostly girls, will donate their time to help physically handicapped children in the 10-day Day Camp that will be held Aug. 12 through 23 in Alondra Park.

Monday through Friday, teenagers will show the children how to create simple objects in arts and crafts and will guide them in group games.

Ten different day camps are run by the Crippled Children's Society and teenagers in each community are enlisted in the volunteer tasks of working with the handicapped youngsters.

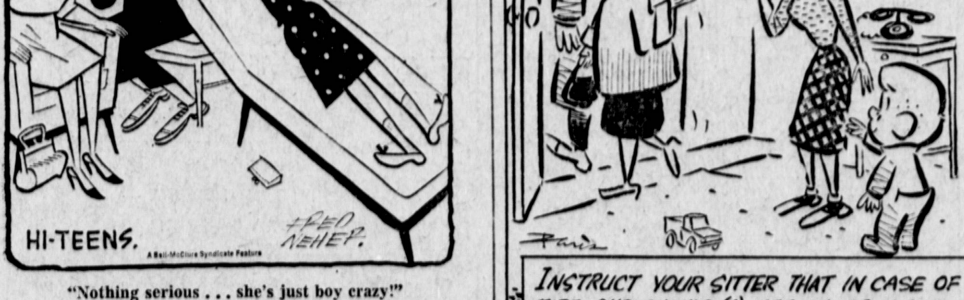
