Annexation Vote Slated By Lomita CC

Members of the Lomita Chamber of Commerce will meet tonight at the Jump 'n' Jack to determine the chamber's stand on the proposed incorporation of the Lomita area.

Results of the questionnaire circulated among the chamber's membership will be announced by E. R. Haslage, manager of the organization. The chamber is expected to determine whether it will support incorporation proceedings begun sometime ago, or lend its voice for annexation of the area by Torrance.

Proceedings on both sides have been at a standstill for some weeks. Torrance has filed 57 separate annexation petitions, taking in areas of the proposed incorporation. Conflicting state laws have been cited, and no action has been taken by either group at this time.
