"Overtake and pass only when you are sure you can make it safely."

In other words, never take a foolish chance. Plan a long margin of safety, never pass in tight situations, and never pass on curves or at hillcrests.

Before passing, motorists should carefully check traffic conditions ahead and to the rear. Look for bridge approaches, narrowing pavement, pedestrian or bicycle traffic intersections, or other conditions which might cause the driver you are passing to make a sudden lane change or to pull in front of you.

YOU CAN never be assured that oncoming traffic in the passing lane will slow down and allow you to complete your pass of another vehicle. Should the person you are

passing suddenly speed up, this would greatly reduce your passing distance. Should this occur, drop back rather than risk trying to complete the

pass.

After you have passed another vehicle, be sure and wait long enough before reassure that you won't cut off the vehicle you have just

passed.

If a driver following you wants to pass you, help him make the pass safely. Keep well to the right side of your traffic lane, do not increase your speed, and be prepared to reduce your speed if necessary to help the other driver complete the pass.
