Home Savings At New High During Year

All-time highs in assets, savings and loans were achieved by Home Savings and Loan Assn. during the 12-month period ending March 31, 1963, according to Kenneth D. Childs, Home's president.

Assets increased \$254,024,253 or 23.6 per cent from \$1,077,349,105 the same date last year for a national record breaking total of \$1,331,373,358.

THE 74-YEAR-OLD association also reported savings accounts now stand at a new high of \$1,185,805,811 an increase of \$237,389,168 or 25 per cent from \$948,416,643 over the 12-month mark ended March 31, 1962. Home Savings paid \$13,626,483 in dividends to its more than 420,000 shareholders for the first quarter of 1963, thus breaking its own national record for the industry.

Real estate loans have increased \$167,651,831 from \$895,136,879 to \$1,062,788,710 during the 12 months ended March 31, 1963.

IN THE NEXT four years Home will construct eight new buildings for association use. Last month the association broke ground for a new three-story Burbank building. This September, Home will open its new Pomona branch, a seven-story structure in the heart of the city's new Pomona Mall.
