AN ORDINANCE OF THE CITY OF TORRANCE GRANTING TO SOCIETY MOBIIL OIL COMPANY, INC. A NEW YORK CORPORATION, A FRANCHISE TO CONSTRUCT PIPELINES AND MAINTAIN A POLYMERIZATION OF HYDROCARBON SUBSTANCES IN THE CITY OF TORRANCE.
