

Three Mile Storm Drain Gets Approval

The Board of Supervisors has approved plans and specifications for the second unit of the South Torrance storm drain which will serve sections of Torrance and Lomita.

In taking the action, the board directed that bids for the project be opened March 6 in the offices of County Flood Control District Chief Engineer M. E. Salsbury.

Estimates place cost of the structure at about \$950,000. The project will involve construction of nearly three miles of reinforced concrete box and pipe drain conduit and includes two separate lines.

ONE LINE begins at Pacific Coast Highway and Hillworth Avenue and runs north in Hillworth and Crenshaw Boulevard to 250th Street, east in 250th Street to Pennsylvania to a junction with an existing drain at 248th Street.

The second line starts at the Main Street-226th Street intersection and runs north in Main to 223rd Street, east in 223rd to Avalon Boulevard, north in Avalon to Carson Street, and east in Carson to the first unit of the project being constructed at Dominguez Channel.

Special arrangements have been worked out to minimize inconvenience to motorists and residents along the drain route.

ONE LINE of the project will pass Carson High School and Dolores Street School. During construction in this area, the contractor will be required to erect a temporary 5-foot fence along the excavation as a protective measure.

Plans for the key drainage facility, which is expected to siphon storm waters from adjacent streets, were prepared under the supervision of Los Angeles County Engineer John A. Lambie. Construction, operation, and maintenance of the project will be handled by the Flood Control District.

Funds to finance the work were included in the \$225 million storm drain bond issue approved by County voters in 1958.

Construction is slated to start within two or three weeks after award of a contract by the Board of Supervisors and is set for completion about 10 months later, Supervisor Burton W. Chace said.
