ORDINANCE NO. 1474  
AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TORRANCE, ADDING SECTION 8.13.1 TO CHAPTER 8 OF THE CODE OF THE CITY OF TORRANCE, PROVIDING THAT EMPLOYEES OF PUBLIC UTILITY CITY ACQUIRED BY THE CITY MAY BECOME MEMBERS OF THE CLASSIFIED SERVICE WITHOUT EXAMINATION.

WHEREAS this City Council de-sires to adopt a procedure relative to employees of a public utility taken over by the City; and

WHEREAS there is no provision in the present Civil Service Ordinance for such employees.

NOW, THEREFORE, the City Council of the City of Torrance does ordain as follows:

**SECTION 1.** That Section 8.13.1 is hereby added to Chapter 8 of the Code of the City of Torrance, as follows:

"**Sec. 8.13.1. Acquisition of utility.** Whenever the city has acquired a public utility, all technical and clerical employees of such utility upon hire may become members of the classified service without examination in the classification which the personnel director designates employees their duties on condition that such employees accepted by the department head and city manager and passes the city employment examination required for city employment in such classification."

**SECTION 2.** This ordinance shall take effect thirty days after the date of its adoption.
