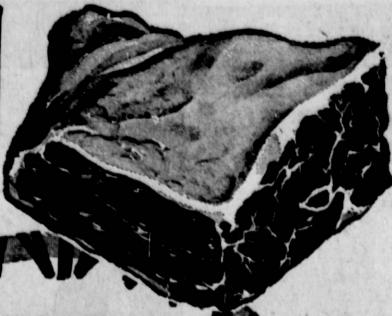

Professor Named to Committee

Appointment of Ralph G. Crouch, assistant professor of city and regional planning in the University of Southern California's School of Public Administration, to a national committee on continuing professional education for Planners of the American Institute of Planners has been announced.
Crouch, who lives at 24263 Los Cadona Ave., has been a member of the USC faculty since September, 1963. He attended Harvard University as a Sears Roebuck Fellow in planning and has worked in Salinas and Monterey.
The new appointee served in the Army of Occupation in Japan after the Second World War. He is a graduate of the University of Michigan and he earned his master's degree there in 1963.
Crouch and his wife, Dora, are the parents of six children.

State Seeks Referees for Appeal Board

Qualified applicants for positions as referees are being sought by the California Unemployment Insurance Appeals Board, according to chairman Gerald F. Maher.
Final filing date for applications is June 5. Examinations will be given in Sacramento, San Francisco, and Los Angeles June 27.
Salary ranges for board referees, who conduct hearings and issue decisions on appeals and petitions under the Unemployment Insurance Code, is \$1,058 to \$1,286 per month. Residence in the state is not required.
Applicants must have five years full-time experience in the practice of law or five years in a responsible capacity, including two years of hearing experience, in labor or industrial relations, public employment security, labor law enforcement, or related fields.
