

# Car Believed To Have Hit Hitchhiker

A 62-year-old man who police said was a hitchhiking transient was apparently struck by a car which left the scene.

The incident occurred about 6:30 p.m. on Pacific Coast Highway east of Madison Street, Edward Quinton Conner was taken by ambulance to Harbor General Hospital where she was treated for injuries to his left hip and thigh and abrasions.

Conner told police he was on his way from Santa Paula to San Diego where he was going to seek employment. Conner said he was walking along the edge of the highway when he was struck from behind by a passing vehicle. Police said the vehicle apparently did not stop since none was at the scene.
