
### **Pressures Added** To Requests for **Traffic Controls**

Pressure from two more sources Tuesday was added to the city's request for more adequate traffic controls at the intersection of Pacific Coast highway and Newton street.

Assemblyman Vincent Thomas, who represents this area, said he is sending a letter to the State Highway Commission drawing attention to the hazardous condition at the location and asking that it be surveyed.

Everett Balcolm, president of the Pacific Hills Home Owners' Association. Inc. is to send a similar letter to the state agency, officials said today. Many residents of the tract use the intersection in going to and from their homes.

The city's request for better controls at the intersection was sent Monday, according to City Manager George Stevens, Accompanied by photographs of one bloody mishap, the request cites accidents which have caused almost 60 injuries and one death in the past three years.



# **Oil Rig Fire** Extinguished

Torrance firemen spent three hours Friday night from about 6 p.m. to 9 p.m. squelching an oil derrick fire at 237th and Walnut streets.

The fire had licked to about 30 or 40 feet up the derrick when the two Torrance fire companies extinguished it.

Viewers remarked on the unusual ability of the men to quench the fire after it had progressed as far as it had. The floor and belt house of the derrick were demolished. Accurate degree of damage has not as yet been estimated.


# Farrar, Rohrdanz timed each day around a course Remain Undefeated
