# **Board to Get Hazing** Issue

Members of the Board of Education will take action on the initiaissue at their Board meeting this coming Tuesday, June 16, at 8 p.m

They have received close to 80 pages of transcripts coming out of a private hearing conducted last week by Judge John Shidler, Board president. Twelve individuals involved in the matter were interviewed at the three-hour hearing, according to Dr. J. H. Hull, superintendent At Breakfast of schools.

In the meantime letters, phone calls, and comments of all sorts have come in to the Press.

#### Varsity Club Letter

One letter, signed by the 17 Varsity Club initiates, and written their own initiative, declared: "We feel that a great injustice is wing done to the Varsity Club as well as to Coach Greybehl who we feel did everything in his power to keep this a safe and sane initiation which we who went through it feel it was just that." The members asked that this signed letter be weighed against "one exaggerated anonymous letter."

All other calls, comments, and letters commended the Press for airing the issue and asked that something be done to remedy the situation.

Dr. J. H. Hull said the school would not "pooh-pooh" the issue and would investigate it properly. On the other hand he did feel that the public response was light and at times critical of the publicity iven to the issue.
