Color Color was added to the controversial hearing when W. L. Geyser, an engineer residing in the Hollywood Riviera stated that aesthetic values must be taken into consideration, though the spokesmen for the tract belittled this. Otherwise we will get sterile engineering thought" with such planning. Then "we could live in floos — they are the most economical from a standpoint of money and, from a stress analysis, also the most efficient."

Frank Morris, building contractor, said an "engineer was a man who knows more and more about less and less till he finally knows nothing. A man should so use his own rights as not to infringe on the rights of another."


