from the underground supply, while 55% is brought in from the Metropolitan District.

As the West Basin water supply diminishes, it becomes necessary to obtain Metropolitan water which is three times as expensive, according to McVicar.

An appropriation of \$9000 as the county's share of the cost for investigational work for the prevention and control of sea water intrusion in the West Basin was approved Tuesday by Supervisor Burton W. Chace.

In establishing the Water Conservation Zone II, the West Basin Water Association seeks to combat the dwindling of the water supply by injecting fresh water into the ground which will also stop the intrusion of salt water.

An indication of what has already happened to the water supply was given by McVicar. Three years ago the Torrance wells drilled 150 feet for water. Since then the level has dropped to such an extent that the wells must go down 187 feet.

The superintendent did not know yet what the cost of this plan would be for Torrance. Carl Fossette of the West Basin Association spoke of a direct charge on the West Basin in the form of a 5-cents-per-\$100 valuation on property. The tax is not a standing tax but has a definite life to it.

Dominguez Estates has indicated that it will try to lead its oil fields out of the proposed zone since they are located in part in the Central Basin and part in the West Basin.
