The area is bordered by Hawthorne, Beryl, 190th St., and Del Amo.

ASSEMBLY SAYS 'O.K.'

\$15 Million Shopping Center Slated For Torrance Airport

A bill which will pave the way for a \$15,000,000 commercial development on the southeast corner of the Torrance Municipal Airport was passed this week without a dissenting vote by the California State Assembly.

A telegram from Assemblyman Vincent Thomas informed the Torrance Press of the bill's passage.

The measure is now headed

for the Senate and observers believe that no opposition will arise from those quarters.

It has been stated that the commercial development would involve a regular business center with a chain drug store, a restaurant, a department store, shoe store, and other stores. Torrance would receive \$200,000 in sales tax from this center, it was disclosed.

Assembly Bill No. 19, introduced in the 1954 special session

of the Legislature by Assemblyman Vincent Thomas, and included on the agenda by the governor, would extend the city's leasing powers on city property from 25 years to 50 years.

A savings and loan spokesman from Long Beach interested in the site told city officials that they could not amortize their investment on less than a 50-year lease.

The bill was introduced by

Thomas at the city's request. City Attorney James M. Hall flew to Sacramento last week to present the city's problem to the Committee on Municipal and County Government.

Proposed Change
Assembly Bill No. 19 would add a section to the Government Code stating:

"37395. A City may lease for 50 years property owned or held or controlled by it, or any of its departments, when not re-

quired for other city purposes, for planned commercial development consisting of retail store buildings, parking facilities, and retail outlets of various kinds for retail use."

City Attorney Hall also spoke on behalf of traffic improvements on Pacific Highway from the Lomita boundary to Redondo Beach. The city formally requested that the entire length be divided and that left turn lanes and other safety features be provided.

4 BOND ISSUES ENDORSED BY INDUSTRIES TAX GROUP

VOTERS TO ACT ON \$1,400,000 BONDS

Four city bond issues totaling \$1,400,000 were endorsed by the Torrance Industries Tax Committee Tuesday, according to Reed H. Parkin, chairman.

Approval was given after City Manager George Stevens explained the need for the improvements called for by the bonds.

The four propositions to appear on the April 13 ballot include a \$250,000 swimming pool; \$700,000 new civic center and police station; \$300,000 fire station; and \$150,000 for recreation facilities.

The present city hall and police station were designed for

a city for less than half the present population, Stevens told the group. As a result, he pointed out, the deficiency of many departments is being impaired for lack of adequate space.

This holds true in regard to the other bond issues as well. The Torrance Industries Tax Committee is composed of representatives of most of the large manufacturing facilities here which carry the greater share of the municipal tax burden.

2 Appointed To Recreation Commission

J. H. Paget, manager of Newberry's, and Mrs. A. E. Collins, of North Torrance, were appointed to the Recreation Commission by unanimous vote of the City Council this week following the resignation of B. F. Johnson and the pending resignation of A. J. Patronsky.

3 Areas To Get Play Program

Three areas will be given a full-time recreation program through the joint efforts of the Recreation Department and the Board of Education, it was disclosed this week.

Such a program will be set up at Seaside and Waverly elementary schools and at McMaster's Park.

Schools
The Board of Education unanimously agreed to let the City Recreation Department organize an after-school, Saturday, and holiday recreation program at the two schools as of April 12. This program will be the same as the recent pilot program at the Perry School.

The program at McMaster's Park will start Monday, March 22. It will run five days a week, Monday through Friday, from noon to 9 p.m. Les Breitenfeldt will supervise the program at the park.

7 Candidates Enter Race For Council

With the dust cleared after the last minute rush to make the filing deadline and with the eligibility list determined, seven candidates emerged this week to contest the two City Council seats; two others will vie for the city treasurer's post; and one uncontested candidate will run for the city clerk's post.

City Clerk Albert H. Bartlett, seeking his ninth four-year term of office, emerged unopposed for the first time in many years.

Ineligible
Of the eight candidates who filed for City Council, Thirvin Fleetwood, 3637 West 182nd street, was pronounced ineligible because of the residence requirement. Candidates must have lived in the city at least one year to be eligible to run for public office. Fleetwood has been a Torrance resident only 7 months. He lived four

Council Candidates Reply..

In an open letter published by this newspaper last week, the Torrance Press invited candidates running for City Council to state their position in regard to the local building scandal. The following replies were received:

In reply to your invitation to answer an editorial appearing in a recent issue of your newspaper, titled "An Open Letter," it appears that a restatement of the facts surrounding the investigation of Tract No. 18540, which resulted in the suspension of the employees of the City of Torrance, is in order.

Upon my recommendation, a group of citizens appeared before the City Council of the City of Torrance to air their complaints relative to certain defects in the homes they occupy in the above named tract. These people were heard by the City Council and by unanimous action of the Council certain investigations by agencies of the State of California were requested.

These investigations were made by officials of the State of California at the Council's request, and their findings indicated that the responsibility lay with the City's Building department.

This is in answer to the open letter referring to poorly constructed houses in Torrance. We, the people, can definitely lay the blame on our Building Inspection Department where plans should be checked over closely before issuing permits. The Department should also see to it that plans and the finished structure will come up to the building code.

If the inspection department finds discrepancies that are not covered by the city code, these should be brought before the City Council for amendment to the present code. This will give our inspectors tools to work with.

With proper cooperation between the City Council and the Building Department, our future homes and the reputation of Torrance will be insured against this recurrence.
