sometime around April 14, according to Walter Bradford, secretary of the Civil Service Board.

The two building inspectors were suspended following a state investigation of alleged building violations in the city of Torrance. The state report recommended the reorganization of the Building Department.

Both Dresser and Smith formally denied the charges in letters sent to City Manager George Stevens.

All Inspections Made

Dresser claims that every one of the required four inspections was made by him or one of his representatives. If inspection records were incomplete in some instances, this was due to circumstances beyond his control, Dresser stated.

He categorically denied that he ever approved construction which was contrary to the plans and specifications submitted "except in minor instances as at the time appeared reasonable and not in violation of the code."

Job Recruits

Further denial was made of charges that he authorized alteration of job permit cards or that he overruled a subordinate's decision to halt work in a tract before building violations were corrected.

While admitting that he prepared plans for residential construction in Torrance and in some cases received compensation, Dresser denies that he was working for such compensation on city time. He did not know any reason why such plans should not then be approved by him, the letter stated.

In a separate letter, Smith denied failing to make any of the required four inspections. Where no inspection record is available, Smith claimed, the omission could be attributed to a clerical error, lack of time, or inadequate facilities at the time.

Smith denied ever altering job permit cards or permitting workmanship in violation of the building code.
