## Arraignment Set For Dope Suspects

Two Torrance men are scheduled for arraignment on felony narcotics charges January 11 in Long Beach Superior Court, according to action taken at their preliminary hearing Tuesday in South Bay Municipal Court.

Released on bail were Jerry Eugene Codd, 21, of 1648 W. 221st st., and Donald Lee White, 22, of 911 Amapola ave.

Both were arrested with two other youths at Codd's home last Dec. 17 by Sheriff's narcotics officers and Torrance detectives. Also taken into custody during the raid were Gary Locke, 21, and Norval I. Wood, 20, both of Lawndale.

As a result of a mix-up, a mistake was made on two addresses in a narcotics story published in the Torrance Press December 21.

Jerry Codd, 22, whose address was reported as 1428 West 221st street, lives at 1648 West 221st street.

David Lee White, 23, whose address was reported as 911 Amapola, lives at 911 Amapola, according to police records.

Officers charged Codd and White with felony and misdemeanor charges, and booked Locke and Wood on misdemeanor possession of drugs charges.
