

### **COUNCILMEN FAVOR** MAYOR-AT-LARGE

Some time ago the Torrance Press recommended that the mayor be elected by the voters in Torrance rather than by the Torrance City Council. The matter also came up for discussion briefly at a council meet-Ting some time ago. Nothing further was said. In an effort to determine how the councilmen feel about putting the matter on the ballot, the Torrance Press asked their opinions. MAYOR ALBERT ISEN: "I have already gone on record

on the matter previously. I'm all for it. It would make the mayor directly responsible to the voters and less subject to pressure from the councilmen who elected him on controversial issues

COUNCILMAN VICTOR BENSTEAD: "It depends on the rest of the set-up (if this should be tied in with an increase in the number of councilmen and the way they are to be felected). I think it's probably all right. It would take a lot of pressure off the mayor politically."

COUNCILMAN WILLYS BLOUNT: "I'm not really opposed to it if there's a need or if that's what the people want.

COUNCILMAN NICK DRALE: "I advocated this right along. The mayor should be representative of all the people."

COUNCILMAN ROBERT JAHN: "I don't see anything wrong with it. I don't know if I'm in favor of it or not, but I would be for putting it on the ballot. I talked against it recently only for the sake of debate (before the Junior Cham-Moer of Commerce) and because of the way it was presented before the council (insufficient details).

Governor Goodwin J. Knight denied that an all-out Republican primary battle between US Senator William F. Knowland and himself next year would be
