Editor's Note: The following are the recommendations referred to in letter.

Section 35114 should be amended to provide that the required signatures must be secured within a period of 60 days from the date of the first signature secured thereon, It should provide further that if the signatures are not obtained, no petition for the annexation of any of the same territory to the same city shall be circulated for a period of three years.

It is recommended that Section 35134 of the Government Code relating to successive annexation elections be amended to provide an interval of three years instead of 12 months as at present.

The arguments here are the same as for incorporation, namely, that when the community has decided the issue it should not be subject to constant harassment by repeated attempts to annex.
