Whitaker of Haw-

Mrs. Mumma has the distinction of being the 'only woman ever to serve on the Board. Russell, who was also a member of the first elected board in the institution's history, served as president of the trustee group from 1946 until 1952. Also elected in the spring of 1947 were Mel Allen of Inglewood, Dr. Lyder, and Jordan Dunaway, who now lives in Rolling Hills. Allen served on the Board for
