# **Dangerous Walk to** New School Charged

Complaints that walkway pavement near the new Hamilton School has created a greater hazard than it was without any sidewalks will be voiced to the City Council Tuesday by a delegation of mothers

All they have done is widen the street," asserted Mrs. Frank Anderson, of 3115 W. 180th St., who spearheaded a petition drive to provide sidewalks on 182nd St for the protection of school children.

After the petition containing 126 names was filed with the City Council Tuesday, street department crews paved a walking strip on the south side of the street Thursday.

But Mrs. Anderson maintains that the paving is on the same level and adjacent to the roadway, and that instead of solving the problem, it has aggravated it. "We want to thank the city for the prompt help, but we'll also tell them that it is not enough," she said.

John V. Russell, director of public works, said that street department crews paved the strip on the basis of plans and specifications received from the Torrance Unified School District for three new northside elementary schools.

Mrs. Anderson said that heavy traffic on 182nd St. poses an especially critical danger. She estimated that approximately 300 students walk between Crenshaw

Blvd. and the school to the east.




