### Schools Battle Fund Cut

The Torrance Unified School District has sent letters to California legislators asking their support in seeing that changes are not made in formulas governing distribution of state and federal aid to school districts.

The local school board addressed letters to Assemblyman Vincent Thomas, Congressman Cecil King, and Sens. Thomas Kuchel and Clair Engle, urging maintenance of present formulas.

The California legislature currently is considering changing the state formula so that districts receiving a large amount of federal aid would receive proportionately less in state aid. Under the formula currently un-

### Planners to Mull Drainage

Proposed sites of major flood control projects will be studied by the Planning Commission for the next two weeks.

In particular, the commission wants to recommend the most favorable location for the Walteria Lake drainage basin, to determine how near to Hawthorne Blvd. it should be located.

The 28-acre sump is designed to drain the entire Walteria Lake area and is to be located northwest of Hawthorne Blvd. and 236th St.

The planners will make their recommendation on the major flood control projects, to be financed out of a \$225,000,000 county bond issue, to the City Council.

Other major drain projects are designed for central and North Torrance, Walteria, and Hollywood Rivera.

### Name Commissioner

The name of Dr. Wilmet J. Labit of 3768 W. 242nd St. for a vacancy on the Park and Recreation Commission will be submitted for confirmation by the City Council Tuesday.

Mayor Albert Isen named him to succeed Robert Cramer, who resigned when he moved from Torrance.

### Bradford Blasts 'Run-Around' from City Department Chiefs

"I'm tired of some department head or commission blocking actions by the City Council," So declared Councilman George Bradford Tuesday night in lashing out at delays in completion of city projects. He criticized acting City-Engineer Ronald W. Bishop for not having plans completed for a drain to alleviate erosion in the Victoria Knolls ac-

tion. The engineer replied that he had received instructions from John V. Russell, public works director, not to start the plans until a test suit decides that the city has the right to undertake the project.

"The same thing happened on

Lomita Blvd. I'm tired of coming up here and getting the same old run-around," Bradford snapped.

City Attorney Stanley Remelmeier said that the city will receive legal clearance to construct a drain in the Victoria Knolls area where houses are threatened with land slippage.

Bradford said the council gave definite orders to have the drain plans started so that work could proceed without delay.

"I think we deserve some answers," he said.

He and Councilman Willys Blount had criticized public works officials for failing to obtain proper permits to open a new section of Lomita Blvd. into Hawthorne Blvd.

So far the State Division of Highways has refused the city an encroachment permit to run Lomita into Hawthorne Blvd.

Blount demanded earlier in the meeting to get a report on the date the city first asked for an encroachment permit.

Several weeks ago Bishop told the council that the State has not granted an encroachment permit because of a possible drainage problem.
