Driver in **Fatal Car Crash Held**

The driver of a car involved in a spectacular crash which claimed the life of a little girl and sent six others to the hospital will be arraigned tomorrow on manslaughter and felony drunk driving charges.

Jerry Mullins, 26, of 12620 S. Figueroa St., Los Angeles, a mechanic, was arrested by Torrance traffic investigators shortly after he was released from Harbor Coneral Hospital, where he was confined since the April 5 crash on Sepulveda Blvd. near Maple

He was freed on \$1500 bail pending his appearance in Torrance Municipal Court.

Killed in the two-car collision which cut Mullin's car in half was his stepdaughter, Shannon Lucille Tillotson, 7.

Critically injured in the crash was the driver's stepson, Randy Tillotson, 6, who suffered a fractured skull, ruptured spleen, broken shoulder and an eye injury.

Two other passengers in Mullin's car also were hospitalized. They are Linda Tucker, 17, of 12620 S. Figueroa St. and Patsy Russell, 14, of 12120 S. Figueroa

in addition, the driver of the other car, William Howard Mar-shall, 47, of Hermosa Beach, and his wife, Hazeldean, 44, suffered fractures.

Traffic investigators said that Mullins was driving his car at high speeds just before the accident and was passing another vehicle when he collided with Marshall's vehicle.
