PUPILS CREATE New mains were put in to take care of certain new subdivisions, but old mains were not replaced but old mains were not replaced as the state Public Utilities Commission demanded when a rate increase was placed in effect. Most subdividers paid for their new mains but because of the fact that the whole system was tied together with rotten lines the pressure cannot be increased substantially or else the lines blow out. Consequently there is insufficient pressure to fight a fire, the area is rated as a hazard, and everyone in Lomita must pay a higher fire-insurance rate.
