

These elusive, unpredictable silver fish are found only on the coast of Southern California, from about Morro Bay, to Ensenda, Baja California. They may be found on the wet sand and after a wave Picking a particular spot is almost impossible; you can't outguess these tiny fish. The month of June is condsidered the best open month for grunion hunting. The fish, which come in on extremely high tides to deposit their eggs in the sand, will usually be found in dark areas. These spawning periods. (March. June, July and August, OPEN season) last three to four nights that follow the full or new moon. Noise of any kind frighten the

little fish and seem to transmit a signal to move to a more secluded area. Using a flashlight is useful, but should be used only when a wave has receded.

Grunion Hunting Regulations 1. A valid California fishing license is required for persons 16 years of age or older,

2. Grunion may be taken on the beach or in the surf by HAND ONLY. 3. No applicance of any kind

may be used and it is unlawful 4. There is no bag limit.
