## Teen Queens to Be Picked

Next Saturday is Torrance Youth Baseball Day, and in honor of the occasion a Baseball Day parade will start at 10 a.m. Approximately 3000 young ball players will participate. The route will be from Crenshaw west on Torrance Blvd. to the Civic Center.

Each baseball league in the city will enter a float. Judges in the float contest are Sam Levy, merchant; Dr. J. H. Hull, superintendent of schools; and Harry Van Bellehem, director of recreation. Three trophies will be presented, for best theme, most original, and most beautiful. Each baseball league will enter a candidate for the title of "Little Miss Little League" (girls between 8 and 12) and "Miss Baseball" (girls between 13 and 16).

Judges for the queen contest will be Mike Callas of the Torrance Press, Mildred Hunt of the Redondo Beach Breeze, and Bill Schepper of the Torrance Herald. Judging will be done before the parade, and the queens will be crowned at the finale of the parade. Music for the parade will be provided by the Torrance Area Junior Youth Band.

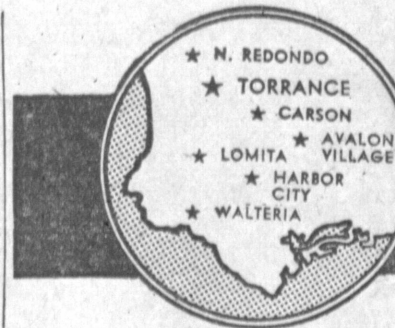

# Fireman to Answer Political Charges

## City Council Slaps Down Standard Oil

Big Company Slugged By Condemnation and Dedication of Land

The City Council, all its years of irritation at Standard Oil bubbling over, this week derived considerable satisfaction in slamming two legal actions on the firm.

The councilmen long have grumbled over Standard's public-relations vacuum here and unanimously played the retaliation for all it would take.

Mayor Isen rejected a city department head's plea that the Standard Oil legal delegation be heard early that they might depart. He held them over for oral communications at the end of the session.

The company's Los Angeles attorney, seeking leave to build a gas station at Madrona and Sepulveda, expressed the firm's displeasure at being required to dedicate a strip of land to widen Madrona.

Councilman George Bradford suggested that some Standard John Doe come down from San Francisco and take a look at the company's intractability here.

"You mean John D. don't you?" quipped Isen.

The council also ordered Robert K. Dower, assistant city attorney, to proceed with condemnation of Standard Oil property at Lomita Blvd. and Crenshaw so as to get on with installation of a traffic light.

The firm wanted \$4000 for this consideration.

The lawyer also declared it was unfair to require the company to dedicate 40 feet of land and install curbs and gutters at the site of the proposed gas station.

"Let's keep the site for a sump," suggested one councilman.

## Fire Stations Plan Open House for Saturday

The Torrance Fire Department will join the statewide observance by holding open house at all Torrance Fire Stations from 10 a.m. to 5 p.m.

At headquarters on Crenshaw, demonstrations are slated at 11 a.m. and 4 p.m., which will include laying hose lines, aerial-ladder rescue, life-line slide, and life net.

No children under 12 will be permitted unless accompanied by an adult.

## Denial of All Counts Due Tomorrow

Attorney to Attack Constitutionality of City, State Statutes

Fireman Dick DeArmitt, through his attorney, Joseph Taback of Beverly Hills, tomorrow will file an answer to charges that he took part in the recent city-election campaign in violation of law.

The answer, to be sent to the Civil Service Commission, will deny all charges.

It further will attack the accusations as violations of the United States Constitution.

Taback said the laws are vague and indefinite as to what is meant by "active participation," they deny free speech, and enforcement of the measures are unconstitutional since hundreds of city employees put election stickers on their cars.

Alluding to a campaign letter written by DeArmitt's wife Lorraine, Taback said that if a law can tell a city employee's family what to do, this is a clear violation of the First Amendment to the U.S. Constitution.

Taback said he expects a hearing before the commission within 30 days.

Unions and backers from all strata have rallied to the fireman's support, and last week the Torrance Fire Fighters and state Fire Fighters indicated they will assist him in taking his case to the U.S. Supreme Court if necessary.

## Council Limits Civic Center to Municipal Units

The Civic Center will be limited to city, county, and cultural buildings, the City Council decided this week.

The Civic Center planning committee recommended exclusion of all but city buildings, court, library and museum facilities, and recreation buildings.

Plans are being prepared by Adams, Morgan, Latham, Kripp, and Wright.

Drawings will be ready in about six weeks.

James Becker, chairman of the committee, said first approval probably will be the civic auditorium.

## Students Hear 300 Experts

More than 300 community experts have been approved for speaking to Torrance school classes during the past two years, according to a report to the Board of Education. These speakers addressed both elementary and high-school audiences.

Speakers on foreign countries led the list.

Other most popular topics included aviation, chemistry, missiles, electronics, grooming, health, homemaking, law enforcement, music and art, physics, and salesmanship.
