John Saltzgaver was best man.

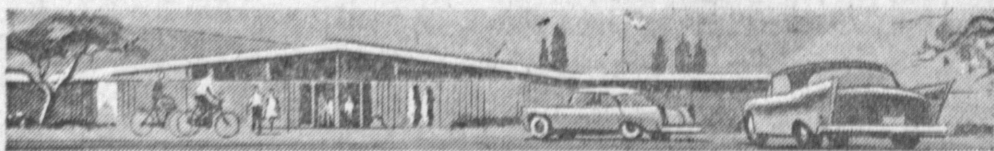
Steven Shaylor, James Watson, and William Staat ushered.
