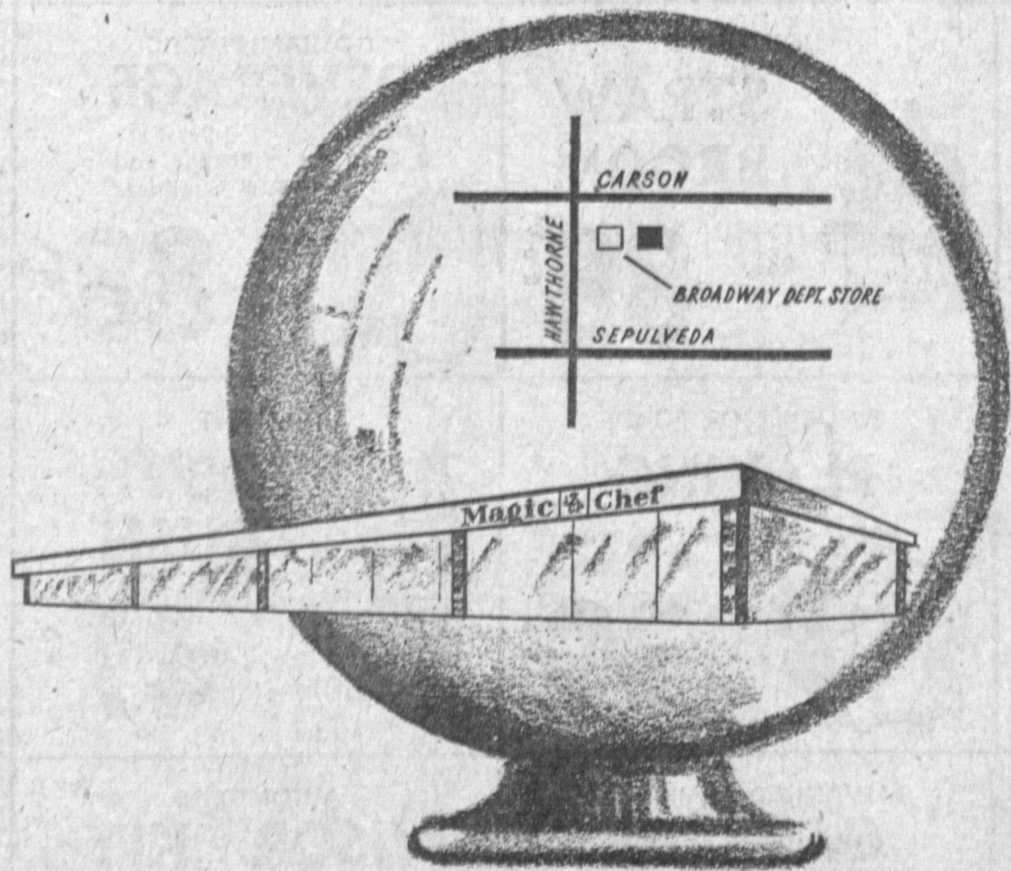

Osteopathic Hospital Slates Weekend Landscaping Party

The Bay Harbor Osteopathic Hospital, now being completed at 1437 Lomita Blvd., Harbor City, will be opened June 15, it was announced by administrators today. The facility, which will provide for 50 beds, cost \$784,000 to build. Cost of the land was \$100,000, and equipment amounted to \$125,000. Architectural fees ran \$67,000, and landscaping and other expenses boosted the total investment to more than \$1,200,000. A landscaping party is being held on the grounds this weekend. Patients, doctors, and friends of the hospital will gather Saturday and Sunday under supervision of Joe and Ruth Sakamoto, nursery and landscape contractors. The hospital has incorporated provisions for two major-surgery facilities and one for minor operations. The building is decorated throughout in rich pastels.
