The Lomita-Crenshaw annexation has been arrested, but may not be dead. An ordinance repealing the annexation in face of a court order has been prepared for City Council approval.

The repeal does not abrogate the city's right to appeal the ruling of Judge Eugene P. Fay, who held with the protestants that their objections as property owners in the area should have been considered by Torrance.

Neither does the repeal prevent the city from instituting annexation proceedings as early as March 31, 1961. The council probably will make its intentions known Wednesday.

Budget Slash of \$8,000,000 Asked by Hahn

More than \$8,000,000 can be cut from the county budget, Supervisor Kenneth Hahn announced today as he listed items totaling \$3,094,167 he will urge the Board of Supervisors to eliminate or defer.

Previously he had itemized appropriations of \$5,079,740 he said he will seek to cut out of the budget.

"If this rigid economy program is followed, it will mean that a reduction of more than eight cents in the tax rate can be made," Supervisor Hahn declared.

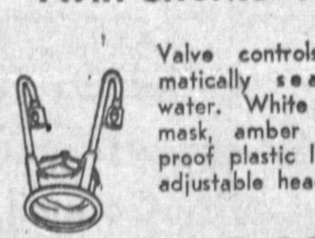
