Torrance Housewife Gets Action from Eisenhower

Mrs. James Stadler, 22414 Warmside Ave., mother of five, until recently found it was all she could do to keep abreast of her personal correspondence and was inclined to leave civic letter writing to others.

That was before she heard about the drafting of Charles Crawford, Lawndale's councilman and teacher at Smith School. Crawford was slated to report to his selective service board June 9, one week before school ended.

Feeling this was wrong,

Mrs. Stadler decided to issue a complaint at top and dashed off a note to the President of the United States appealing the selective service status of the councilman and teacher.

"I think educated persons are needed more in the schools and on the city councils than in the army," she told the Press.

Last Wednesday she received a letter from Col. Dee Ingold of the Selective Service Board in Washington stating that "outstanding induction orders had been cancelled."

On July 13 the Lawndale Draft Board will make a final decision on the matter.

Mrs. Stadler isn't acquainted with Crawford and this was her first letter to an official.

"I never before thought of writing when I read or heard of something I felt needed further consideration," she said. "But I certainly will from now on."

Mrs. Stadler will discuss the reasons that prompted her to write on Ben Alexander's TV show early in August.
