County Sees 'No Need' for Vote Machine Spending

At a meeting called this week by Supervisor Kenneth Hahn of key County officials, it was established that there is no need for the County to spend another \$2,000,000 in buying electronic vote counting machines (on top of \$1,000,000 already spent developing the machine over Hahn's opposition) when the job of counting ballots from Los Angeles County can be done better and faster by improving administrative procedures and by establishing regional vote tallying centers.

"By strengthening existing state laws covering election procedures and by using regional vote tallying centers it will be possible for final results of elections to be known by 7 a.m. the day following elections," Supervisor Hahn declared.

OFFICIALS PRESENT

In attendance at the meeting were Registrar of Voters Benjamin S. Hite, his chief assistant James Allison, Chief Administrative Officer L. S. Hollinger, and County Counsel Harold W. Kennedy.

Supervisor Hahn explained that the election board officials in his own precinct and in a number of other precincts in the same area which he visited last election night all had finished counting the ballots before midnight of election day.

It was pointed out that about half of the precincts had completed their task of counting all of the votes on all candidates and issues by about midnight but that the balance of the precincts reported later than that—some as late as 10 o'clock the following morning.

Hite indicated that the major problem in setting up the plan described by Supervisor Hahn would be in getting the individual precincts—of which there are nearly 12,000 in Los Angeles County—to submit their returns earlier.

Improvements Necessary

However, he stated that he felt that a number of improvements could be made which would speed up precinct returns. He pointed out that nearly 60,000 citizens serve on the election boards in Los Angeles County and that final returns are submitted from precincts to his office beginning at about 8 o'clock the evening of the election until after noon the following day. The majority of the returns, however, are submitted before 2 a.m. the day after election.

He would not explain why there should be such a wide variance in the time it takes the various election boards to complete their count.

It was agreed by all present that the following changes in the election procedure laid down in the state laws would expedite the counting of ballots in the precincts:

TWO MEMBERS

1. Legislation to allow two members of the election board to count ballots. Present law requires all five members of each board to count the ballots. If the law is amended it would double the speed of counting the ballots because each precinct would have two teams, instead of one, counting the votes. Hite admitted that many of the precincts are now following this procedure.
2. A provision which would give the Registrar of Voters the power to go beyond adjoining precincts to provide election officials in precincts where there is a shortage of qualified manpower. At present, only adjoining precincts can be used to meet manpower shortage problems. This change would also make it possible for government employees to serve as election board officials where manpower shortages exist.
3. Simplification of the ballot wherever possible—particularly in eliminating from the ballots judges who are unopposed for re-election.

PLANS FOR SPEEDUP

Supervisor Hahn's plan for speeding up the counting of ballots includes the following steps:

1. The voter follows the same procedure as at present marking his ballot in secret.
2. The precinct election board officials follow the same procedure as at present—starting the counting of ballots after the polls are closed and posting the results outside the door.
3. The precinct results are taken to a regional tallying center where they are tallied. For example, if 10 regional centers are used, it would mean that each center would have to tally or add up the total vote of about 1,250 precincts on each candidate and each issue.
4. The total tally from each regional center would then be sent by special messenger to the Registrar of Voters main office at 808 N. Spring where the regional tallies would be added together for the final results.

"This procedure would guard the sanctity of the ballot box and would make it possible for all of the returns of Los Angeles County—which has more registered voters than 42 of the 50 states—to be declared officially by 3 a.m. the day after elections," Supervisor Hahn declared.

Expect Yule Phone Calls To Set Mark

With the Christmas season near, Pacific Telephone is preparing for another record holiday spurge of calls that may top the 400,000 mark for one 24-hour period.

Attempt to Fire Own Home Brings Arrest for Arson

Torrance arson investigators last week arrested a retired painting contractor on charges that he attempted to burn his own home.

Officers said that Virgil Newberry, 59, of 1027 Portola Ave., was taken into custody after he apparently tried to set fire to the house by touching off cleaning waste soaked in paint thinner.

Firemen were called by excited neighbors and extinguished the blaze before damage could be done.

Newberry is alleged to have told investigators that he soaked rags and newspapers with the thinner in order to burn the house "to clean it up."

He was booked on suspicion of arson and then committed for psychiatric check at Los Angeles General Hospital.
