'Population Is Major Factor in City's Future

The hotly contested proposal to rezone 155 acres near the intersection of Crenshaw and Sepulveda from industrial to residential usage will be brought before the City Council Tuesday night.

Don Wilson, prominent Southland builder, has indicated that he will construct more than 600 homes in the area provided that the council agrees to rezone the land.

Opponents to the plan support the contention that the city is running short of industrial land and that the acreage should be retained in its present M-2 classification, awaiting the day that some industry takes notice and decides to move in. Members of the city's planning commission have gone along with this idea and have voted 6-1 to recommend against changing the property's zoning classification.

READY FOR YEARS

Yet proponents of the plan to build homes on the weed-covered parcels have pointed out, with unfailing logic, that this land has been available for industrial development for many years but has not been utilized.

Opposition to the measure paint glowing pictures of the huge amount of industrial taxes that will be gleaned, SOMEDAY, when the acreage is developed.

Civic minded residents who support the move to rezone point out that new homes and new residents in this city would take upon their shoulders a part of the stifling tax burden already carried by homeowners. With a "bird in the hand" philosophy, they point out that residential taxes NOW are far better for the community than a gout of industrial taxes in some distant, and quite possibly imagined, future.

OTHER USES

Available land for industry has been reduced consid-erably in the past four years. Yet the large majority of this available industrial land was not used for industry

Largest proportion of this M-zoned land that has disappeared from the available list has been re-classified and is presently being used for commercial purposes.

Many of the community's newest shopping centers and discount houses are nested, quite comfortably, on industrial land.

Yet a project that would provide new customers for these commercial stores, which were gladly received by the same people who are presently opposed to develop-, ing the Marble Estate tract, and which would provide an economic boost to the community, is being opposed.

NO TAXES

Petitions are presently being circulated stating that rezoning of this area would bring about a hike in taxes, yet virtually no taxes are presently being paid on this undeveloped land.

Revenues derived from the development of the tract into homesites would certainly offset the present high tax rate in this community.

Considerable opposition to the plan to rezone this industrial area from M-2 to R-1 classification have been noted by members of the local school board, who have reported that they MAY have to build a new school in the area if the homes are constructed.

Yet the building of new schools should not be a deterrent to progress, nor should it halt the exciting growth of Torrance.

This city's population has expanded by 400 percent over the last decade, a fact that has made it outstanding throughout the United States and has brought the title of All-American City here.

If the building of a new school was a factor in the equation the city of Torrance would have died on the vine many years ago instead of becoming the thriving, progressive community it is.


