Chemical Company Distributes Cash In Employee Fund

A cash distribution of \$328,187 under an employee savings plan in which the company adds as much as 30 per cent of the employees' savings was made on Friday to 283 employees of the Torrance plant of Union Carbide Chemicals Company. The employees saved \$244,340 of their own money through this plan during the last two years and the company added \$83,847. Union Carbide Chemicals Company is a division of Union Carbide Corporation.

Under this plan, employees set aside up to 7½ per cent of their earnings and the company adds 10, 20, or 30 per cent to this depending on whether the employee has one, two, or three or more years of company service.

Plan contains provisions for short-term savings and long-range investments or a combination of both. This flexibility, which is one of the outstanding features of the plan, permits employees to set aside cash for a distribution every two years and also provides the choice of long-range investment in either U. S. Savings Bonds or Union Carbide stock. Savings plans were made available to Union Carbide employees as early as 1935.

Recreation Men Receive Status Through Board

Richard Leach of Lomita was among 29 individuals throughout California recently to receive Certificates of Registered Recreation Leader, issued by the California Board of Recreation Personnel, following examinations at Fresno, Los Angeles, Oakland, Sacramento, San Diego, and Ventura.

The 29 new registered recreation leaders will join 744 other registered recreation leader personnel within California, according to announcement by Harold Teel, Chairman of the State Board and Chief Deputy Director of Parks and Recreation for Los Angeles County.

The system of issuing Registered Recreation Leader Certificates under a voluntary registration plan was launched on January 1, 1955, by the California Park and Recreation Society.

1. To establish minimum professional standards for leaders in recreation.
2. To certify to the qualifications of those professionals employed within California.
3. To clearly identify leaders engaged professionally in organized recreation.
