

Women's Groups Join Campaign To Fight Cancer

The American Cancer Society today joined forces with the Federation of Women's Clubs in Los Angeles County in an all-out program to "Conquer Uterine Cancer."

Mrs. Robert L. Brown, Cancer Society Education chairman and a member of Governor Brown's Advisory Committee on Cancer Control, stated flatly that uterine cancer is practically 100 percent curable if diagnosed in time.

"During the past year, 14,000 women died of uterine cancer; these deaths didn't have to happen," she said.

The county-wide drive will be spearheaded by members of Women's Clubs in six Los Angeles County districts, working closely with American Cancer Society volunteers.

"Our immediate objective," she explained, "is to have every club member report for a health checkup and a Pap smear examination; then to schedule regular periodic examinations as a preventive measure. Ultimately we hope that every woman in Los Angeles County will do likewise."

During the past 25 years, deaths from uterine cancer have dropped 50 percent and

Mormon Church Celebrates Day Of Independence This Saturday

There are many Independence days celebrated throughout the world in July; America's Fourth, the birth of the Philippines and France's Bastille Day. But one Independence Day is seldom thought of or even mentioned. It occurs here in the United States. More than 1,500,000 people celebrate it as a day of religious freedom; freedom to worship God as they please, freedom from mob violence, tyranny and governmental interference.

July 24, 1847, and for 13 more years, Mormons (members of the Church of Jesus Christ of Latter-day Saints) arrived in the Salt Lake Valley from Illinois. Thus, July 24, became Pioneer Day to the Mormon communities in the United States.

This year marks the 114th anniversary of that fateful day when Brigham Young led the first group into what is now known as Salt Lake City, Utah.

From many articles, papers, diaries, and books the story of this tremendous migration can be pieced together. Religious persecution drove the Church from New York State to Ohio, Missouri, and Illinois. Mobs would burn, pillage, and rape.

Government protection was not forthcoming. At last the members of the Church were driven from their most beautiful city, Nauvoo, Illinois. Under the leadership of President Young the people crossed the Mississippi and headed west. This was with-

ter—so cold that one night the mighty Mississippi river froze hard enough for oxen and wagons to be driven across.

From this unimaging beginning things became worse. The pioneers suffered from plague, exhaustion, starvation, and some were even frozen to death. Childbirth occurred without rest or shelter. Still they came, on knowing they would at last be free to worship.

In the spirit of respect and gladness for their accomplishments, this year the Redondo Stake is having a Pioneer Day Celebration. The festivities will be held July 22, from 10 a.m. to 11:30 p.m. Games, booths, contests will be held. There will be square dancing outside and ballroom dancing inside. A real beef
