Highway Patrol Approves Safety Brake Device

Last week California Highway Patrol announced approval of 56 air brake safety devices. Purpose of the safety devices is to automatically apply the brakes on any vehicle equipped with air brakes in case air pressure fails.

Approval has been long awaited by safety experts and is the result of a state law passed in 1959. This law (Section 26310, California Vehicle Code) requires that all vehicles with air brakes be equipped with such a device.

According to estimates by the California Highway Patrol this law means a cost of from \$200 to \$300 to California public carriers.

According to the law safety devices must be installed before March 15, 1963. Many vehicles sold since the law was passed already mount the devices.

Passage of the law followed a series of runaway truck accidents. One of the most serious killed 13 people in San Francisco.

The approved devices generally provide one of two types of emergency braking capacity — automatic application of brakes through an emergency power source, or retention of sufficient air in the system to permit effective application of the brake.

Marina Savings Announces New Lawndale Facilities

Marina Federal Savings and Loan Association has just announced that as a result of official approval from the Federal Home Loan Bank in Washington, D.C., and under its authority, a new office of this Federal Savings Association will soon be available to citizens of the Lawndale area.

"Two prime parcels of land have been purchased in Lawndale," reports Russell Chase, president of the association, "one is the planned site of a new multi-storied banking building to be constructed in the future, and the other will provide parking facilities for customers."

A temporary Lawndale home will be established in a building shared with the Metropolitan Insurance Company, 17000 Hawthorne Blvd. These headquarters will take up the entire south wing of the building shared with the Metropolitan Insurance Company, and will be entirely remodeled to suit Marina Federal Savings' specific needs for providing efficient service to Lawndale residents.

THIRD LOCATION
Active in the Westchester-South Bay area, with offices in Westchester and Torrance, Marina Federal Savings counts the Lawndale area as the logical place for the establishment of its third office.

"The next decade is bound to see a cementing of purpose for the newly incorporated city of Lawndale," said Chase, "and the need for a Federal Savings and Loan organization was clearly evident to governmental authorities who granted permission for its establishment."

Choice of site was dictated by the trio of major arteries by which the purchased land is bordered. The San Diego Freeway runs to the north, adjacent to the west is Hawthorne Blvd., and on the south is Redondo Beach Blvd., and 174th St.

Marina Federal Savings has had a remarkable record of growth in the Westchester-South Bay area. Original capital in 1956 stood at a figure of \$500,000. Assets as of Sept., 1961 are recorded at \$40,000,000.

Ronald D. Oland, active in a supervisory capacity at the firm's headquarters in Westchester, will head up the new Lawndale office.
