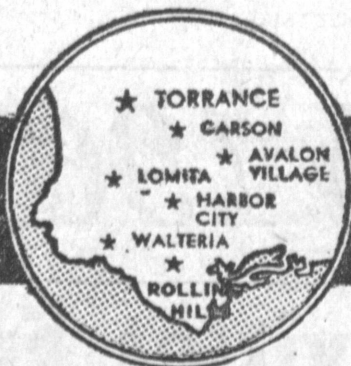

Council Queries Newsrack Law

Hearing Set Today
On Injunction in
News Stand Case

Red hot issue of whether or not the newsstands of the Socialist Labor Party publication, The Weekly People, should remain on the streets of Torrance, and whether they could be removed without infringing upon the rights of other newspapers, came up for discussion again at Tuesday's city council meeting.

Mayor Albert Isen opened the issue by commenting that the hearing on a Superior Court injunction, prohibiting interference with the operation of the news racks, would be heard today in the Los Angeles courtroom of Judge Gordon Files.

INSULT

Noting the racks, which were replaced by the distributor after their disappearance early last month, were now linked with heavy

chain to two 75-pound blocks of concrete, he stated that he felt that the chaining down of newsstands was a "calculated insult to the people of Torrance."

Isen is also the defendant in a \$5,020 damage suit, filed for the publication by the American Civil Liberties Union, for his alleged involvement in the disappearance of the original racks from two Torrance locations.

On a suggestion by councilmen J. A. Beasley, matter was turned over to City Attorney Stanley Remelmeier for study and the possible preparation of a regulatory ordinance.

"We have a city attorney and we have a police department," said Beasley. "If we have a law on the books that these news racks are violating its up to them to take care of it."

Four-Year-Old Dies
After Tumble Into
Dominguez Channel

A 4-year old Torrance youngster fell to his death Monday afternoon while playing on a bridge across a drainage channel at 169th St. and Arlington.

Pronounced dead on arrival at Little Company of Mary Hospital was Jules Anongoes, 3404 W. 186th St.

Mother of the youngster, Mrs. Loretta H. Anongoes, told police investigators that the youngster had never wandered so far away from home before. Usual place for the youngster to play, she said, was an empty field down the street.

First report that the youngster had fallen from the bridge into the 25-foot

deep, concrete lined channel, was phoned to Torrance police by Mrs. Angus Granlund, 16910 Arlington, who lived nearby.

According to police investigating the accident, the youngster had apparently been playing on the bridge, climbed on top of the three and one-half foot guard fence and then tumbled to his death.

When hurriedly summoned police and fire units arrived at the scene they found the bridge and channel banks crowded with neighborhood residents. However, apparently no one witnessed the youngster's fall.

One resident of the neighborhood reported;

"The bridge is an irresistible attraction for youngsters. They play here all of the time. Every adult around here does his best to keep them away from it but we can't be on watch all of the time."

City councilmen at Tuesday night's meeting, commenting upon the number of calls going through the city's switchboard following the accident, stated that the responsibility for maintaining the safety of the channel and the bridge belonged with the County Flood Control District. They pointed out that the safety rail was only installed after a vigorous protest by the city.
