

Noted Organist Presents Concert Next Weekend

To celebrate the opening of the new Hammond Organ Studios of the South Bay, Orville R. Foster, internationally-known organist, teacher, author and composer, will present a local concert at 4 p.m., Sunday, January 7, in the Retail Clerks' Auditorium at 5940 Belle Porte, Harbor City.

The public is invited to attend the concert, according to sponsor Ken Chilton, owner of the new Hammond Organ Studios, located at 2768 Sepulveda Blvd., Torrance.

Foster, who owns and operates the Foster Organ School in Long Beach and is a faculty member of Long Beach City College, recently completed a 50,000 mile tour of the United States and Canada, giving concerts and training over 1,000 teachers. His instruction books and courses in organ instruction are considered the standard for teaching in the field, according to Chilton.

There will be no admission charge for the concert, Chilton explained, and reservations may be made by phoning Davenport 6-1131.

Cooperation of Courts Halts Costly Litigation

In a report to Supervisor Kenneth Hahn, chairman of the Board of Supervisors' Committee on the Courts, Superior Court Presiding Judge McIntyre Faries this week revealed how intensive efforts on the part of judges to arrange settlements on complicated cases which would require long civil trials have proved effective.

To illustrate to Supervisor Hahn the value of the procedure, Judge Faries submitted a report from Judge William B. Neely which indicated that a settlement had been achieved in such a case in two days of intensive discussion in the Judge's chambers. If the case had gone to trial, it would have taken between five and eight weeks to complete.

TWO CASES

The litigation involved two cases which had been consolidated and which concerned for damages caused by earth movement which allegedly resulted from the cutting of a slope and the removal of lateral support in a subdivision.

Judge Neely stated that he did independent research on the problem and indicated to the litigants the ruling he would make predicated on proof of a certain factual situation.

As a result, and with the objective cooperation of the parties to the suit and their attorneys, it was possible for the case to be settled in a manner fair to all and without the necessity of the long trial.

"This intelligent approach to these long complicated cases is to be commended," Supervisor Hahn declared, adding that the procedure not only saves thousands of dollars in the cost of operating the courts but also helps to clear up the congested court calendar.
