News Of Servicemen

Army Pfc. Charles W. Lauterbeck, son of Mr. and Mrs. Joseph Lauterbeck, 21120 Dalton Ave., Torrance, is scheduled to participate with other personnel from the 9th Infantry in Exercise Great Bear, a joint U.S.-Canadian winter maneuver in Alaska, Feb. 12 to 21.

The exercise will test cold weather military doctrine and the ability of the two allied armies to work together as a fighting team. Exercise Great Bear will be conducted in the vicinity of Tanacross and Eielson Air Force Base, one of the most rugged areas over which an Alaskan maneuver has ever been held. Principal terrain features in the 3,200 square-mile maneuver area are the heavily forested lowlands of the Tanana river valley and the mountains, which range as high as 4,000 feet, converging on both sides of the valley.

Lauterbeck, a rifleman in Company E of the infantry at Fort Wainwright, Alaska, entered the Army in September 1960 and completed basic training at Fort Ord, Calif.

The 25-year old soldier is a 1954 graduate of San Pedro High School and attended Harbor College in Wilmington.

Before entering the Army, he was employed by Pacific Telephone and Telegraph in Los Angeles.

His wife, Carol, lives in Fairbanks, Alaska.

Emphasis is placed on the teamwork and self-reliance required in assaulting a fortified position, combat in towns, vertical envelopment by helicopter and coordinating tank and infantry tactics.

Every new marine undergoes this combat training upon completion of recruit training.

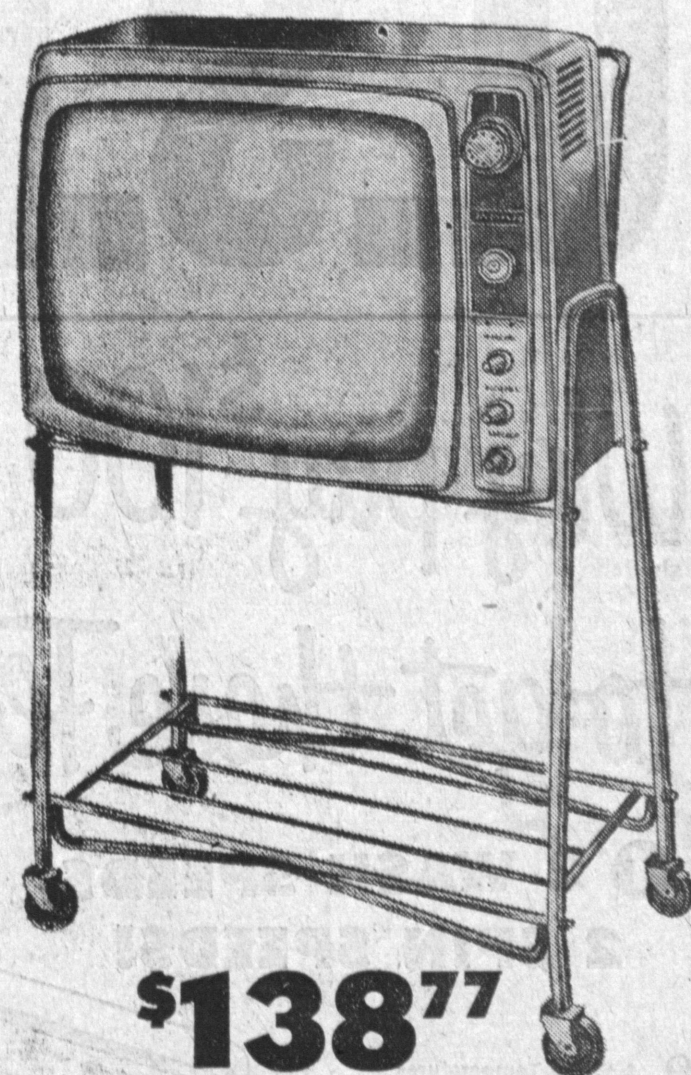
