Major Industry Favors Airport Revenue Bond

Fred Mill of the Industries Tax Committee said major industries in Torrance are in favor of the Airport Revenue Bond proposal that will be up before the citizens of Torrance at the next election Tuesday, April 10.

On the proposal as drawn up by the city, money would be paid by the revenue from the airport to retire the bonds. This would mean the city could have an improved airport at no cost to the taxpayers.

Total cost of the airport improvements paid by the issuance of revenue bonds will be \$1,225,000. Matching funds from the federal government will be used on certain projects that will qualify for the aid as authorized by the Federal Aviation Administration.

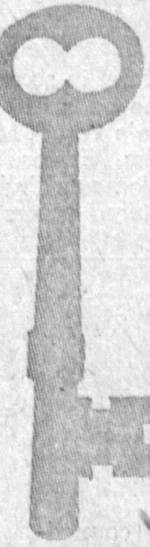

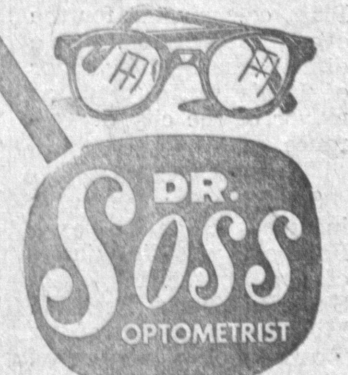

Montgomery High Science Club in Aerospace Tour

On Thursday, March 1, the Sigma Rho Science Club of Bishop Montgomery High School, under the direction of Father Leo, visited Aerospace Corporation in El Segundo. At the very beginning of the tour the club members were impressed with the security of the place. Each member signed in and received a badge which was carefully checked by the guards at each new destination.

The members were introduced to the Aerospace Corporation by engineering heads, who explained the functions of the corporation and its three-fold division, research and planning, engineering, and laboratories. A tour of the laboratories followed and actual experiments were conducted by the scientists for the group.

Dr. Walter Lehmann explained the spectrometer and showed how it is used to identify compounds. A five minute analysis of human breath was performed to show its constituent parts. In the fuels laboratory, an experiment between phosphorus trifluoride and chlorine

Seek Annexation to Light District

"Twenty-five street lights may be obtained in the future for four streets in the Carson area," County Supervisor Burton W. Chace disclosed this week.

A petition is currently being circulated to annex 223rd St. from Figueroa St. to Main St. County Lighting Maintenance District No. 1670. The proposed annexation also includes Joel St. and Figueroa St., Moneta Ave. and Main St. at their intersections with 223rd St.

"Twenty-two 4000-lumen incandescent lights will be installed on wood poles on 223rd St. if the County Board of Supervisors approves the petition," Supervisor Chace said. "Also, one light each will be installed on Figueroa St., Moneta Ave. and Main St. at 223rd St. The Southern California Edison Company will install the lights with overhead wiring."

He advises, however, that the petition must have the signatures of property owners representing 25 per cent of the assessed valuation of all property along the streets being annexed in order to receive board consideration.

"Interested residents should contact Gerald W. Shanahan, 22225 Moneta Ave., in Torrance," Chace stated. "He is handling the petition."
