DEFER LIFE SENTENCE . . .

Court Resets Hearing Date on New Trial For Torrance Area Youth; Now April 30

Final sentencing, and bid for a new trial, in the case of Billy Romain Smith, has been reset for April 30, it was reported yesterday by court offficials. Hearing had formerly been scheduled for to-

Intense interest in the case developed throughout the area following an interview, carried exclusively in the Torrance

Press, with the suspect's pretty 18-yea old wife, Sharon K. Smith.

Floods of letters, many of which were carried in the Press' Letters to the Editor column, have been received by this newspaper, each feeling that the conduct of the trial and the earlier police procedures following the arrest of the 21-year-old suspect, were "irregular."

NEW TRIAL

In the interview, which was carried in the April 1 edition of the Press, Mrs. Smith said that she had instructed the family attorney, Robert Krause of Long Beach, to seek a new trial for her husband, convicted on charges of kidnapping and assault, and pointed out that each time one of the alleged offenses was committed her husband had been in the presence of qualified witnesses who had testified to this effect at the

She said that one of the court officials had chosen to call them "alibi witnesses" and had possibly influenced the jury to disregard them.

In one particular instance, she said, at the exact moment the alleged crime took place, her husband was with a group of 13 people celebrating the wedding anniversary of her parents.

Mrs. Smith further point- charges.

ed out that her husband, in no way, answered the description originally given the police by the victims, had never owned clothing such as the assailant is alleged to have worn and had never owned a gun such as the assailant is alleged to have carried.

DESCRIPTION

Original reports stated that the suspect was 5'10" tall, weighed about 185 lbs., and had dark bushy

Smith is approximately 5'5" tall, weighs about 130 lbs., and has worn a crew cut for years.

Smith, a cook, was arrested by a police stakeout in January. At that time county and city strip police agencies were under considerable pressure because of a series of laundromat holdups, kidnappings and assaults.

Defense attorneys are also investigating the possibility that a youth, arrested recently in Newhall following a series of identical crimes, might be the local marauder.

The Newhall suspect answers perfectly the original physical description given by victims to the police.

Mrs. Smith Friday thanked the Press for its efforts in her husband's behalf and pledged a continuing fight to prove his innocence on all of the

Opens Fire With Gun Concealed Under Folded Newspaper

An upset Torrance resident, at one time part owner of a Redondo Beach insulation company, shot and killed two of his former partners Friday

He also fired a shot at another former partner, but missed.

Under arrest is Wesley DeLane Johnson, 37, of 5216 Beran St., accused of killing Edward John Mello, 38, of Manhattan Beach, and Richard Jones.

35, of Inglewood. Joseph Ambriz, 27, of Hawthorne, the third partner, said that Johnson fired one shot at him and that he fell as though hit. He said that Johnson apparently assumed that he

Ambriz told investigat-

ing officers that the four had started the company as a mutual interest but that Johnson had been drinking, neglecting his work and taking out more money than we were making" and that the partners had forced him out in early January.

Friday evening, he said, Johnson appeared at the offices of the firm and demanded to be let back in.

When the trio refused, Johnson pulled a 38-caliber revolver from under a folded paper and opened Redondo police praised the efforts of local law en-

She convinced him that resistance was useless and he turned the pistol over to her. She then called Pattishall and Bell, who made the arrest.

Johnson was turned over to Redondo Beach detectives for questioning and booking.

Mrs. Johnson told officers that he was also part owner of a similar insulation company in Fontana, and said that he had been "unhappy and brooding" since his eviction from the Redondo Beach

AIRPORT REVENUE BOND . . .

Flying Trip to Capital by Councilman, City Attorney Assures Speedy Passage

Two Torrance city officials made a flying trip to Sacramento Thursday in a successful effort to secure ratification of the airport revenue bond issue before the State Assembly

and Senate recessed. Newly reelected Councilman J. A. Beasley and City Attorney Stanley Remelmeyer reported Friday morning that the two houses had "ratified the bond issue with a concurrent resolution in the shortest time in the history of the Assembly and

the Senate.' Total time, from its introduction into the Assembly to a final voice ballot by the Senate, was just one hour, Beasley said.

CREDITS

The councilman credited Assemblymen Vincent Thomas and Jesse Unruh. Senator Richard Richards, and Lt. Governor Glenn Anderson with helping speed the bill through the legislature.

As a concurrent resolution the bill doesn't require the signature of Governor Edmund G.

Brown. "We had to get the resolution passed now or wait until next year," Beasley said.

He pointed out that the approval by the legislature of the bond issue would save nearly a year in time and a great deal of money, in adding the improvements to the municipal airport.

"Waiting a year before purchasing the land would have forced the city to pay an additional premium because of increased values," he said. "As it now stands the city can release the bonds immedi-
