



Young Dancers Will Present 'Cinderella'

"Cinderella," with Prokofiev's beautiful music, and the eternal magic of a fairytale coming to life, will be presented Saturday, May 4, at the Redondo Union High School auditorium.

Dancers in the ballet have rehearsed with two professional dancers—Guy Stambaugh, as the "Prince of Cinderella's dreams, and Tony Savino as the Dance-Master and jester.

Stambaugh, a dancer and teacher of international reputation, comes from Mexico and the Republic of El Salvador where he held the official title of professor of classical ballet and choreographer for the national ballets of both countries. Prior to that he toured North and South America as the partner of prima ballerina, Mia Slavenska.

Stambaugh has also appeared in many of the great opera houses in Europe as a leading dancer with the original Ballet Russe. He started his dancing career with the Metropolitan Opera in New York, and was last seen on Broadway as a featured dancer in Agnes De-

The evening's entertainment will be concluded with the combined choir and band presenting "Born to Be Free," a hymn to America by Williams.

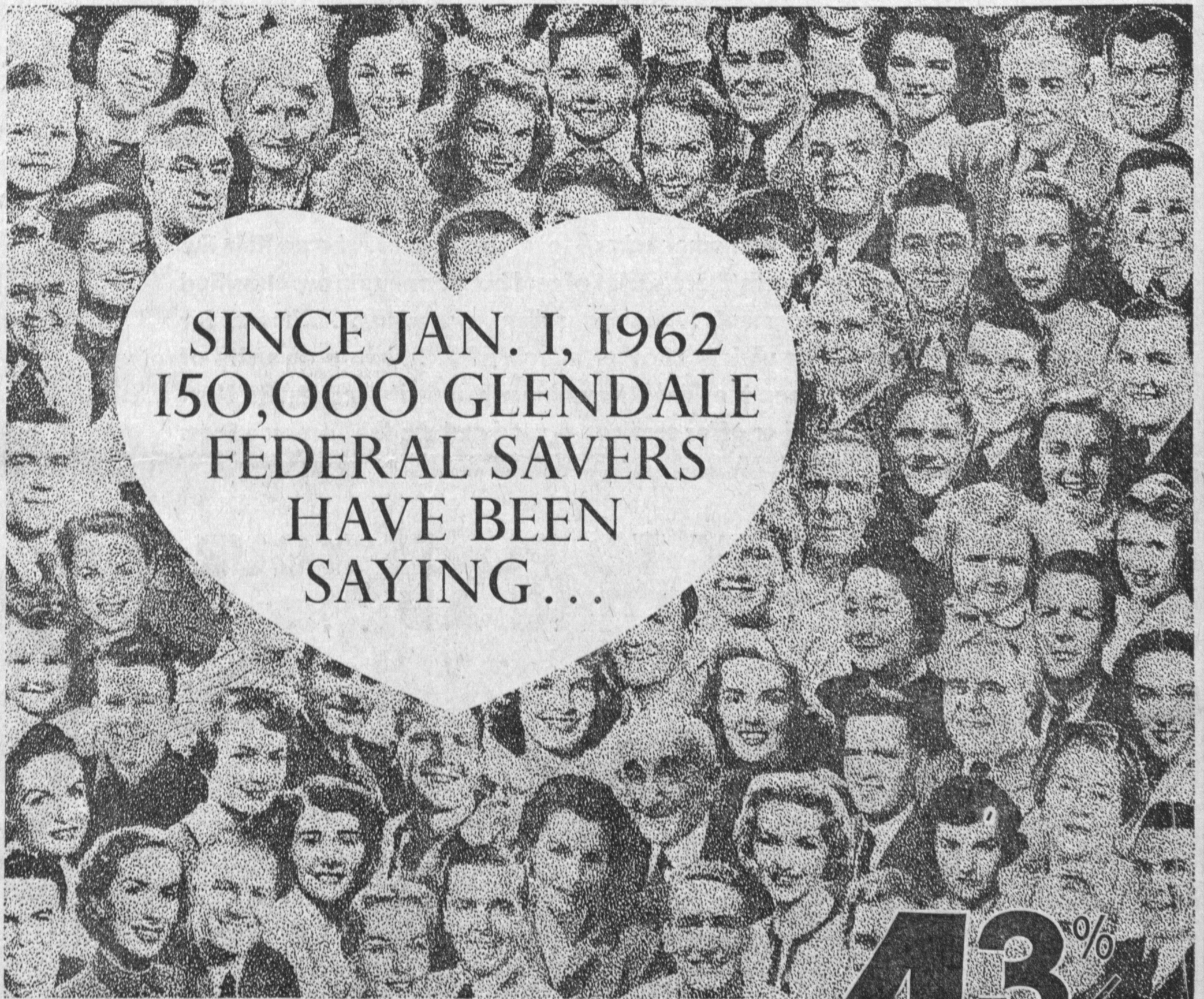
Rolling Hills Man Heads Space Program at NAA

The current issue of The Saturday Evening Post salutes Harrison Storms of Rolling Hills, California. Charged with leading the module makers in their assignment is 46-year-old Harrison Storms. His official title is President of Information Systems Division of North American Aviation. For his unique technological work force, wiry (five-foot-ten, 150 pounds) Harrison Allen Storms Jr. is a unique manager with a mixed-up mandate that involves profit and patriotism, exploratory science and expedient speed, hard labor and human life.

Mr. Storms' men are building Apollo, the crowning spacecraft of a gigantic rocket vehicle designed to reach the moon. In terms of money, Storms and company will operate with the largest single contract ever granted by the Government's National Aeronautics and Space Administration, \$400,000,000 to start with an an assurance of more money if necessary.
