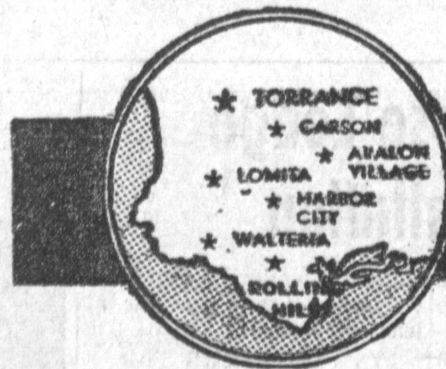

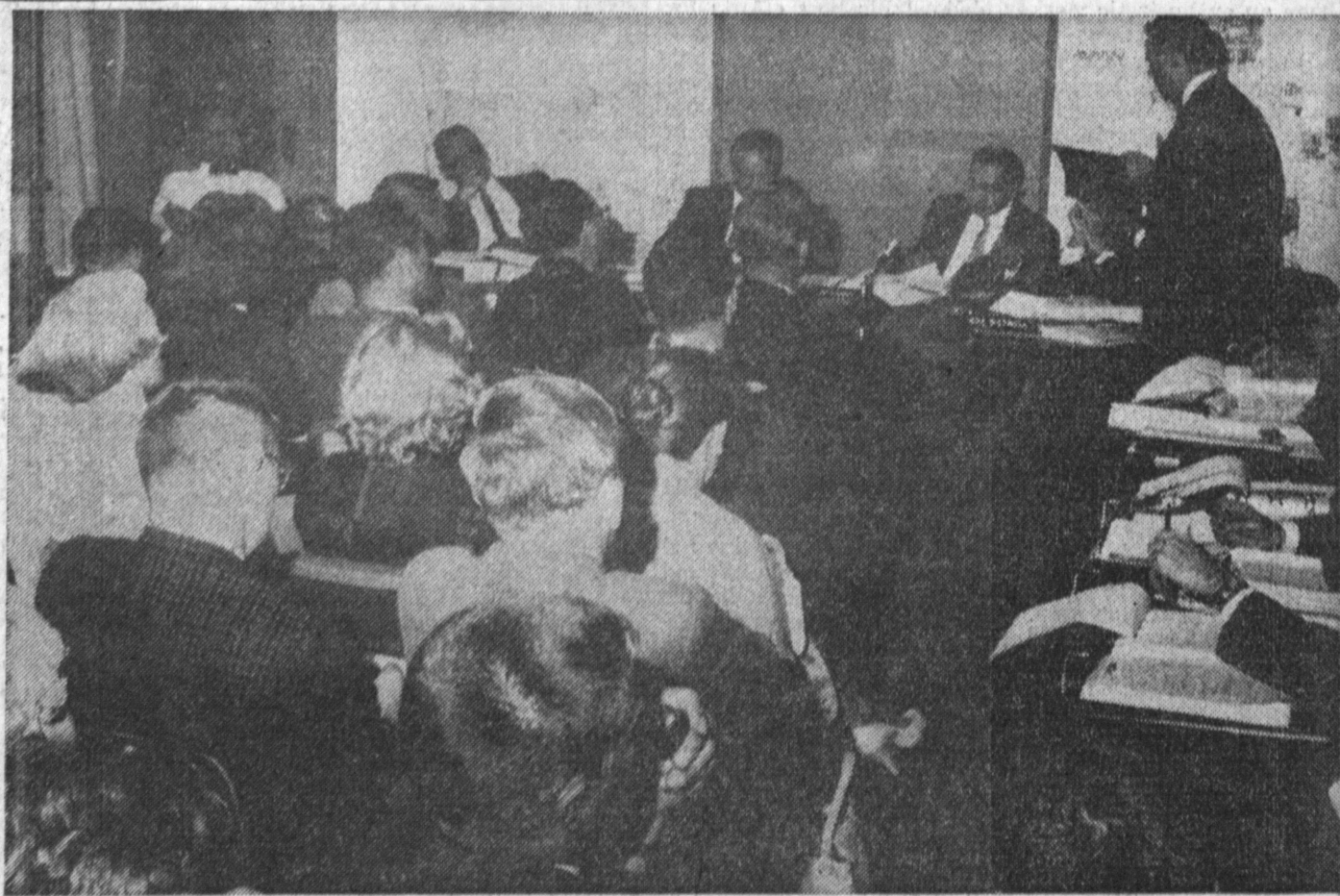

Council Approves Central Torrence Parking Area

Torrence city councilmen last night agreed to kick off proposed downtown Torrence revitalization program by purchasing a portion of land adjoining the Bank of America and converting it into a parking area.

However, the councilmen stated, downtown merchants should show their good faith and confidence in the future of the area by establishing an assessment district to purchase lots for other parking areas.

Cost of the purchase was estimated at approximately \$100,000.

Appearing for a large group of property owners in the downtown area were George Binder and Sam Levy. Binder stated that his organization could promise the signatures of some 40 percent of the property owners in the area, and was certain that the other 20 percent would be easy to acquire. Mayor Albert Isen, commenting upon the move, stated,

"The majority of the council feels that the city should take the first step in this important project. Then it will be up to the downtown property owners to recognize the necessity for dressing up the district, providing proper parking facilities, and of maintaining it."

Calls for \$8-Million Construction Bond Election Sept. 18

Members of the Torrence school board were introduced Monday night to the largest budget in the district's history and stated that they would ask recommendations from local businessmen before launching budget sessions.

Budget, submitted by Dr. J. H. Hull, superintendent of Schools, called for expenditure of \$13,672,624 during the 1962-63 fiscal year—a whopping \$1,700,000 over the current budget.

Board members, four of whom ran for office last year on a program of rigid economy, are expected to take formidable cuts out of the proposed budget before it is finally approved.

Tentative budget must be adopted by the board before July 1.

S. E. Waldrip, assistant superintendent, stated that this year's estimates have been predicted on a tax rate of \$3.1768 for each \$100 of assessed valuation and an estimated 10 percent increase in taxable property.

In a second action the board approved calling an \$8,000,000 school bond election on September 18.

Money will be used for capital projects, including the construction of new schools and classrooms.

September date for the election was approved after

Waldrip stated that the money would be needed before the April school election.

Earlier, it had been suggested that the board place the bond issue on the April ballot for purposes of economy.

However, it was noted that, if the election was held on the later date, it would be necessary to curtail construction on several projects, including the expanded Torrence High School and elementary school building program, until more money could be acquired.

Recognizing the need for continued construction, a board recommended the earlier date.

Troop of Torrence Scouts Credited with Saving Life of Youth Injured in Fall

A group of Torrence Boy Scouts, on a weekend outing in Little Tujunga Canyon, Saturday were credited with saving the life of another youngster who had toppled over a cliff.

Gaining, but still in critical condition, in Pacoima Community Lutheran Hospital, is Larry Combs, 11, of Saugus. Combs and other companions were traveling along the rim of the canyon when the youngster slipped and fell 30 feet into the rocky bed of a stream.

Young companions of the youth ran back along the trail until they met members of Torrence's Troop 728, under the direction of Scoutmaster Raines, 1203 Kornblum

Ave. Raines and Nap Bilodeau, 923 Cerise St., institutional representative for the troop, lifted the youngster from the water to a sandbank.

blum St. address, and Randy Tyler, 16, 1207 Cranbrook, the group built a stretcher of materials at hand and carried the injured boy down the trail to where the autos were parked.

The youth was placed on the floor of a camper and driven to a ranger station several miles away. Rangers, in turn, made a radio call for an ambulance.

Physicians at the hospital stated that Combs was suffering from multiple deep laceration and fractures of both arms, a possible fractured skull and internal injuries. They credited the prompt actions of the Torrence scouts with possibly saving the youngster's life.
