## King of Belgium Bestows Honor on DeOtis Loring Marlett at Luncheon

DeOtis Loring Marlett, the Great Lakes Carbon executive, today was conferred the rank of Knight in the Order of the Crown by King Baudoin of Belgium.

Consul General Frans Taelmans, acting on behalf of his king, bestowed the decoration on Marlett at the Los Angeles Chamber of Commerce World Trade Committee luncheon. Consul Taelmans declared that the award was accorded by His Majesty in recognition of Marlett's leadership in stimulation of the Belgian economy by building a major plant in Ghent, Belgium, to produce filter materials under the firms Dicalite trademark.

### ACCEPTANCE

In accepting the honor, Marlett cited his company's experiences in Belgium to debunk the idea that foreign investment takes away U.S. jobs, and strongly opposed change tax rules to remove U.S. Treasury proposals to incentives for foreign investment.

Great Lakes Carbon has large filteraid producing plants at Lompoc, Calif., and Antonio, Colo. Marlett explained, and in 1960 established a plant in Belgium to provide a base of operations to supply the northern European Common Market with certain grades of filteraids for food processing, sugar and beverage industries.

Belgium was selected for the plant site after extensive studies by Stanford Research Institute comparing that country with alternative areas in Europe on the basis of port facilities, labor, transportation, utilities, tariffs, taxes, financing and sales opportunities.

### FIRST YEAR

"During the plant's first full year of operation in Belgium," he stated, "our total sales of filteraids in North-

ern Europe jumped 175 per cent. However, included in this total were export sales of other grades of filteraids shipped from our California plant to Northern Europe, and these increased by 94 cent."

Marlett attributed this increase of California exports to the improved technical service, education and customer relations made possible by activities of the foreign subsidiary. In addition to increased sales, he noted that further U. S. dollar income would result from payments by the subsidiary for patent and trademark licenses, service fees and purchase of U. S. raw materials.

### INCOME

"Our experience is not unique," Marlett noted. "We have had similar results from our filteraid plants in Mexico City and Milan, Italy. Other manufacturers can tell similar stories. In fact, figures from the U. S. Department of Commerce show that the U. S. dollar income in 1961 from direct foreign investment exceeds outflow by more than \$1 billion, and this favorable balance of payments does not take in-

to consideration increases of export shipments generated by the foreign investments."

Accordingly he urged the Chamber of Commerce World Trade Committee to oppose current U. S. Treasury proposals to the Senate Finance Committee for a tax bill that would discourage foreign investment by taxing profits from U. S. subsidiaries in developed countries at the time incurred rather than when the earnings are repatriated to the U. S.

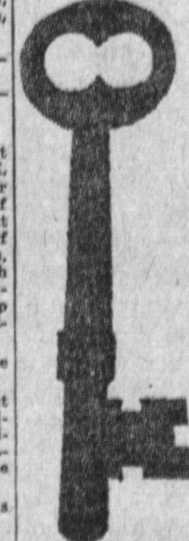
