Study Urgency Of Lomita Zoning

Preservation of a portion of Lomita Pines as a single-family residential neighborhood was assured by the Los Angeles County Board of Supervisors today through the enactment of an urgency R-1 zoning ordinance.

The action was urged by Supervisor Burton W. Chace, who said he has received a petition from a majority of property owners in the neighborhood which is currently zoned R-2.

Approximate boundaries of the area affected are 261st St., 264th St., Cayuga and Applan Way.

The urgency zone will remain in effect until the Regional Planning Commission conducts a thorough study of the permanent zoning needs of the neighborhood.
