

## Reserve Officers Class Enrollments Opened

Enrollment of U.S. Army Reserve officers for the 1962-63 school year is now being offered in the command and general staff associate course at the Fort MacArthur USAR school.

Identical instruction is offered at weekend classes at Ft. MacArthur and at branch evening classes at Pasadena, Santa Ana, and San Diego from September, 1962 through June, 1963.

Two weeks annual active duty classes are required at

Ft. MacArthur, San Francisco, Oakland, or Seattle at different dates in July and August, 1960. Full pay and allowances are authorized. Sixty retirement points are earned annually.

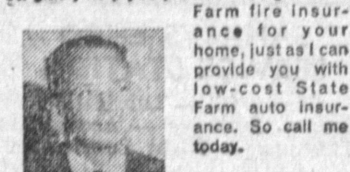
Pre-requisites for enrollment in the associate command and general staff course are: 1. Certificate of completion or constructive credit for branch advanced course; 2. Not have Passed 45th birthday by Sept. 1, 1962. Waivers for age may be granted.

Enrollment for the Fort MacArthur, Pasadena and Santa Ana classes can be completed at building 939, upper reservation, Ft. MacArthur, on May 13, 26 and 27; June 9 and 10; July 8; August 5, 19, or any day between July 15 and 29. Enrollment for the San Diego classes can be accomplished at the USAR School at Ft. Rosecrans.

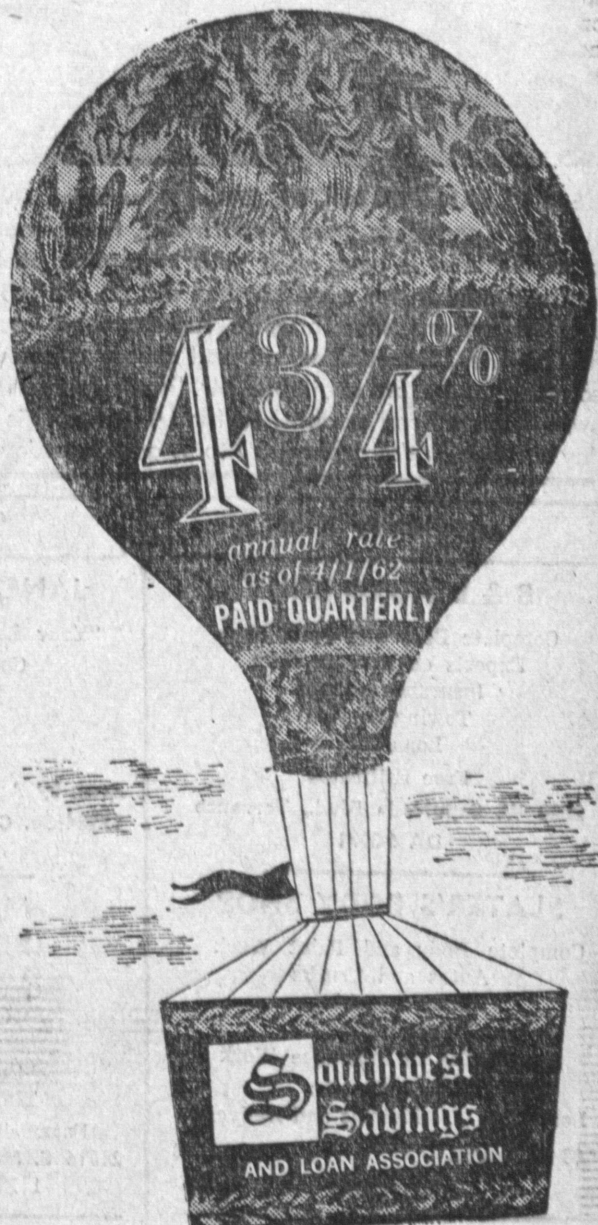
