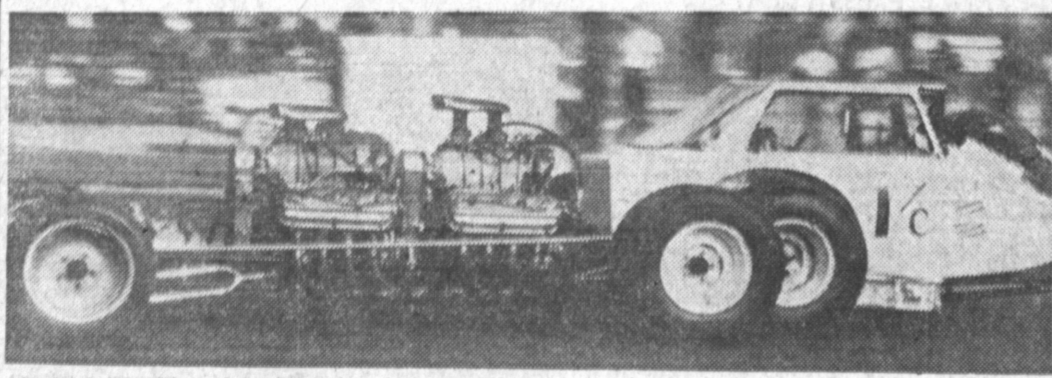


ALL-AMERICA FLOWERS
