The above-mentioned check or bond shall be given as a guarantee that the bidder will enter into contract if awarded the work or any part thereof and will be declared forfeited if the successful bidder refuses to enter into contract after being requested to do so by the District.

Each bid shall be sealed and filed with the Assistant Superintendent of Business, on or before the time and date shown above. Bids will be opened and read in public in the office of Mr. S. D. Waldrip, Assistant Superintendent of Business, located at 2308 Plaza del Amo, Torrance, California.

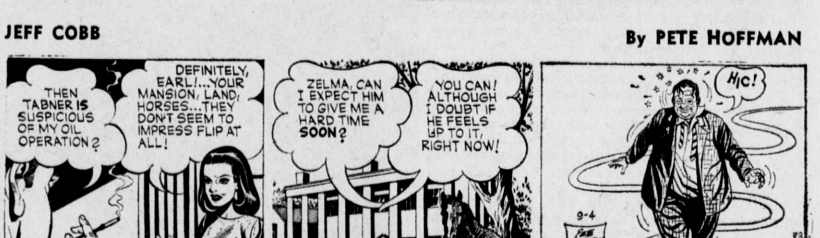
