IN A FOURTH hearing, councilmen will consider a petition by Dan E. Butcher and Financial Savings and Loan Association for a conditional use permit which would permit a cemetery in the south section of Tract 2200.

The 55-acre cemetery, if approved, would be located south of 235th Street and north of a railroad right-of-way.

Approval of the cemetery has been recommended by the Planning Commission with the provision that funeral processions be restricted to 235th Street. The Airport Department also has recommended approval.

A plan of development acceptable to the Planning Commission will be required as a condition of approval under the commission's recommendations.

IN OTHER hearings, the council will consider:

- A change of zone from R-3 to C-3 on property located on Sepulveda Boulevard at Border Avenue.
• A reduction of required parking for Abbey Rents, Inc., at 23845 Hawthorne Ave.
• A parking variance for a 21-unit apartment at 23015, 23025, and 23035 Madison Street.
• A parking variance for a proposed office building on Palos Verdes Boulevard in the Riviera Village area.
