Board Buys 5th School Site Home

Purchase of a fifth parcel of land for the North of Fries Elementary School has been by the Los Angeles City Board of Education.

Milo Watt, director of real estate for the school district, said the land is at 24815 Broad Avenue.

It includes a three-room residence and garage and was sold to the School Board by Michael and Dora Parra for \$14,500.

The property is the fifth of 35 parcels on the west side of Broad Avenue between 246th and 249th Streets being acquired by the Board of Education for a new elementary school.

Seek Grade Crossing in Dominguez

County supervisors have voted to seek Public Utility Commission approval to construct a new grade crossing on Del Amo Boulevard west of Wilmington Avenue.

Supervisor Chairman Burton W. Chase said Del Amo Boulevard is designated a major highway on the county's master plan.

The overpass is proposed, he said, because of a new subdivision in the area, and access will be needed by extension of Del Amo west to Avalon Boulevard crossing the spur track.

The work would be performed as a county road department project programmed for Del Amo between Avalon and Alameda Street.
